## NOTIFICATION FOR DIRECT ADMISSION (PHASE-III) TO B.A. LL.B. (Hons.) / B.Com. LL.B. (Hons.)

Applications are invited from interested candidates for direct admission to the remaining vacant seats available for the Academic Year 2020-2021 for B.A. LL.B (Hons.)/B.Com. LL.B (Hons.) degree programmes. Few Vacant seats are available in the various categories, subject to variation.

Candidates should have appeared in the Common Law Admission Test (CLAT) 2020. Admissions will be granted solely on the basis of their CLAT score. The candidates should apply directly to Tamil Nadu National Law University (TNNLU) through the online application form (with payment of Rs.500/- towards application processing fee ) available on the website ([www.tnnlu.ac.in](http://www.tnnlu.ac.in)) which is displayed under the caption '**Application for UG Direct Admissions 2020**' on or before 10.00 a.m. on 28.10.2020.

**The candidates already applied for Direct Admission (Phase –I & II) and declared as ineligible are eligible to apply if they come under the cut-off rank fixed for this Admission Notification. Such candidate have to apply once again with payment of application processing fees.**

**The Candidates who are waitlisted in the Direct Admission Phase- II Need not apply again.**

The Merit list will be published in the website of TNNLU on 31.10.2020

### ELIGIBILITY

1. Pass in Higher Secondary (10+2)/CBSE/other examination recognized as equivalent thereto with not less than Forty Five percent (45%) marks in case of candidates belonging to Unreserved/Backward Classes (Others) (BC(O))/Backward Classes (Muslim) (BC(M))/Most Backward Classes (MBC)/Denotified Communities (DNC)/Specially Abled Persons (SAP) and other categories, and Forty percent marks (40%) in case of SC/ST candidates.
2. The applicant should be a candidate who participated in the CLAT-2020.
3. The candidates who have secured a rank upto the CLAT ranks in the following category wise ranking are only eligible to apply:

\* Candidates belonging to Tamil Nadu State SC/ST/Converted Christian Scheduled Castes categories and first generation graduate need not pay tuition fee for admission, since the Government of Tamil Nadu has instructed that the tuition fee (Rs.1,00,000/-) need not be collected from the Tamil Nadu SC/ST and first generation graduate students.

\* In the event of **discontinuation**, the student has to remit the tuition fee of Rs.1,00,000/- since the Tamil Nadu Government will not pay to TNNLU in respect of students who discontinued the programme.

\*\* All Candidates are informed that the User Charges of Rs.82,000/- (Rupees Eighty two thousand only ) shall be collected after the campus reopens in proportion to the remaining Academic Year 2020-2021.
